Pool Party Agreement

POLICIES

1. Party hosts must be Fairbrae members.
2. In order to host a pool party, you must also complete an **Outdoor Party Agreement**.
3. Any group of more than ten (members, non-members, children and adults are all included) people that will be using the pool must fill out an **Pool Party Agreement** and have the event approved by the Board or Club Manager at least one week in advance of the event. Outdoor parties are limited to at most 40 people (again, members, non-members, children and adults are all included). Multiple parties may be scheduled on the same day as long as there are not more than 40 people scheduled for Outdoor Parties at any given time.
4. One adult is required to be present for every ten children under 18 years of age.
5. Pool parties will not be scheduled Sundays with club BBQs, Memorial Day, the 4th of July or Labor Day. Pool parties will not begin before noon on weekends.
6. When there is already lifeguard scheduled to be on duty, one additional lifeguard is required for a group with up to 20 attendees under 18 years of age, two additional guards for a group with 21-40 children.
7. When no lifeguard is scheduled to be on duty, one lifeguard is required for a group of 11-15 attendees under 18 years of age, two guards for a group with 16-30 children and three guards for a group with 31-40 children.
8. Regardless of the size of the party, at least two guards must be on duty for use of the deep end/diving well.

9. Lifeguards will be hired for a minimum of two hours each.
10. The host member will be billed \$20.00 per lifeguard per hour.
11. Cancellations or reschedules less than 72 hours in advance will be charged the full amount for scheduled guards. Cancellations or reschedules less than eight days in advance will be charged \$10.00 per scheduled guard hour. Other cancellations or reschedules will be charged a \$20.00 flat fee.
12. Approval of a pool party is dependant on the availability of Fairbrae Lifeguards. **You may not bring your own lifeguards.** All lifeguards must be employed as lifeguards by Fairbrae Swim Club.

I have received a copy of the FAIRBRAE SWIM CLUB POOL PARTY AGREEMENT and have read and understand the rental guidelines. I **understand that I may incur additional cleaning fees and that I am responsible for any and all damage caused by my rental.** I also understand that **the reservation is not official until the Manager or Head Lifeguard confirms the availability of lifeguards.**
